Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 12,808 Elia Group shares during the period between 11 October 2021 and 15 October 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 12,909 Elia Group shares.
