## Purchase and sale of Elia Group shares in the context of the liquidity agreement

Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 8,940 Elia Group shares during the period between 22 August 2022 and 26 August 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 5,040 Elia Group shares.
