Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 13,941 Elia Group shares during the period between 5 December 2022 and 9 December 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 15,201 Elia Group shares.
