Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 9,250 Elia Group shares during the period between 19 December 2022 and 23 December 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 9,105 Elia Group shares.
